#### Course Objective

To provide applicants with the practical skills and knowledge to safely operate a personnel and materials hoist **(HP)** in accordance with Safe Work Australia's National Standard for Licencing Persons Performing HRW. All training and assessments are carried out by our own HRW trainers and assessors certified by Worksafe Victoria.

#### AET Course Entry Requirements

Applicants must be 18 years of age to undertake the training and assessment.

Students are required undertake a Language, Literacy, and Numeracy test as part of the enrolment process and must meet the LLN standard that the RTO has determined as appropriate for entry into the course (students must have the ability to read, write, speak, and understand basic English, and understands basic mathematics which includes the use of formulas)

#### Training Methods

##### Knowledge

- Face to Face Classroom, training knowledge course guide, with the use of white board, DVD's, samples of equipment, simulated workspace and or role play.
- Questioning, observation, working through student workbooks, course assessment.

##### Performance

- Trainer to demonstrate full hazard identification of performance area, risk controls to ensure a safe working environment.
- Demonstration of the performance criteria for the safe operation a personnel and materials hoist in accordance with the Australian Standards by trainer and student.
